SUB.: AMENDMENT/ADDITION IN AFFILIATION BYE-LAWS OF THE BOARD -RULE
3.3(i) CHAPTER II-Reg

Consequent upon the recommendations of Affiliation Committee made in its meeting held on 20.06.2017 and subsequently approved by the Governing Body in its meeting held on 29.06.2017, the following amendment/additions in Affiliation Byelaws as Rule No.3.3 (I)a has been made.

Condition to submit No Objection Certificate will not be applicable to categories of schools stated at Rule 3.1 (i) to (iv) of Affiliation Bye- laws of the Board.</p>	<p>Rule 3.3(i) - The school seeking provisional affiliation with the Board shall submit the following documents</p> <p>(a) Formal prior Recognition letter from concerned State Education Department i.e. Recognition for classes I to V required for Middle Class Approval and Recognition for classes I to VIII required for Provisional Affiliation upto Secondary Level</p> <p>AND</p> <p>(b) No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with CBSE No Objection Certificate once issued to any school will be considered at par even if it prescribed a specific period and /or level unless it is withdrawn. Condition to submit No Objection Certificate will not be applicable to categories of schools stated at Rule 3.1 (i) to (iv) of Affiliation Bye- laws of the Board.</p> <p>Rule 3.3(i) (a) - The schools in foreign countries seeking affiliation with CBSE, shall submit NOC from the Embassy of India/High Commission of India located in that country along with the permission to run the school from the Education Department of that Country stating that the school fulfills the prescribed norms of that country. The schools in foreign countries shall also possess the minimum area of land as specified by the Government of that country. The ownership of land/building/premises shall also be in favour of school/society/trust/company running the school or leased in favour of school/society/trust/company running the school in accordance with the prevalent government norms of the respective country.</p>
